

The Fayetteville Public Education Foundation is honored to announce the establishment of the **Class of 1969 Fund**; an endowed Fund is established in perpetuity and distributed annually in the Class of 1969's name through the Fayetteville Public Education Foundation's grant and scholarship process.

- The minimum amount to establish the Class of 1969 Fund in the endowment is \$25,000. The Class of 1969 Fund will be a commutation of gifts totaling \$25,000. An endowment Fund is not activated until the minimum funding level has been reached.
- The Class of 1969 Fund may be designated for a specific purpose, program, or department.
- The amount distributed to grant recipients is based on the merit of the application. The amount distributed to a scholarship will be up to 5% of the value of Fund. All awards will be within the parameters of the Class of 1969 Fund agreement and equitable to the initial gift amount.<sup>1, 2, 3</sup>
- Classmates may pledge their gift amount in payments for up to five years.

<sup>2</sup> Annual distribution is three to five percent (3-5%) of a 36-month rolling average of the endowment value. This allows for any fluctuation in the investment portfolio. The endowment value is made up of principal, realized and unrealized gains, interest and dividends. Administrative fees are applied annually at 1% of the overall endowment market value.  
<sup>3</sup> Agreement for fund distribution is executed upon establishment of the Fund.
